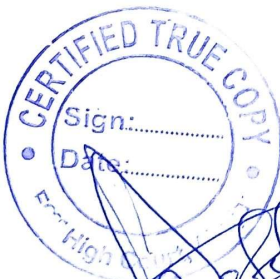

COURT ORDER

Accordingly, the application is hereby granted as in the following terms.

In particular it is hereby granted as follows:

1. An order of interlocutory injunction is hereby issued restraining the 3rd Respondent, its agents, servants, officers, privies or assigns from releasing, transferring or otherwise dealing with the sum of N1, 450, 287, 277.96 (One Billion Four Hundred and fifty Million Two Hundred and Eighty Seven thousand Two Seventy Seven Naira and Ninety Six Kobo) or, any part thereof, standing to the Credit of the 1st and 2nd defendants pending the hearing and final determination of suit No. ZMS/GS/3/2025 before this Honorable Court.

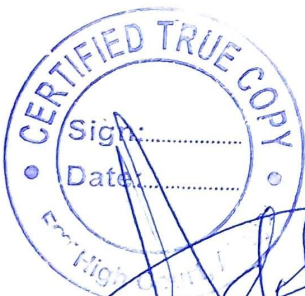

2. The 1st and 2nd Respondent is hereby restrained whether by itself or by its directors, shareholders, officers, affiliate servants, agents, privies or assigns from tempering, transferring, drawing, debiting, transferring, dissipating or otherwise dealing with the funds in its account in any manner whatsoever in the 3rd defendants custody particularly in the sum of N1, 450, 287, 277.96 pending the determination of suit No. ZMS/GS/3/2025 before.
3. Any monies/sum beyond the sum stated supra which serves as the res in suit No. ZMS/GS/3/2025 belonging to the 1st and 2nd defendants may lawfully be utilized by the 1st and 2nd defendants as they deem fit. Such sum is not affected by the order of this Court.
4. The 1st and 2nd defendants/respondents are ordered to refund and restore to its original state all, monies and funds otherwise disposed dissipated or transferred during the pendency of suit No. ZMS/GS/3/2025 to its affiliate company's account domiciled with 3rd respondent in any manner whatsoever.
